<u>Our goal</u> is to come to consensus on our recommendation for 3224 and 2151/3500. If there is time, we will discuss 2410 and the discipline policies.

    - The committee reviewed both 3224 and 3224P as well as the three building dress codes. Additional input was given. Review the stick figure from Debbie S.
      can we use this idea in each secondary school? There was not consensus on that question.
- Policy and Procedure 3500 and 3500P Athletics and Activities

 The committee reviewed 3500 and 3500P and staff recommended these are retired when/if 2151 is adopted.

Policy and Procedure 2151 and 2151P Interscholastic Activities

- Review WIAA standards and current policy and procedure. Consider review and recommendations related to current status and impact of policy related to student participation, academic performance, and district philosophy.
- Discuss staff proposal to retire Policy and Procedure 3500 and use 2151 and 2151P as the only applicable policy/procedure.
  - The committee discussed the following questions:
  - How will the change to WIAA academic eligibility impact participation?
  - Is a three-week at HS and a two-week at MS reasonable/appropriate for ineligibility after the six week mark?
  - Will these changes encourage more participation?
  - Will these changes leverage athletics/activities for better academic effort?
  - Will these changes enable administration of a system?
- The recommended edits were shared and discussed. The committee recommends that staff work on the attendance and ineligible sections.
