Proposal to State Legislators for a Bottle Bill – Lois Sherwood and Students

Members of the High School Students for Sustainability Club explained they plan to propose a bottle bill to the State legislature, and have been working with Representative Mike Chapman to prepare that bill for next year's legislative session. This bill would allow for a deposit to be charged on beverage bottles; then the bottles could be returned for a refund, which would encourage recycling and reduce waste. Superintendent Polm reported there are no recommended changes to this policy, as the procedures outlined in these policies have been effective when needed.

Director of Finance and Business Operations - Amy Khile

Ms. Khile reported on enrollment for April, 2017, a budget status for all funds, a capital levy and bond analysis, a report on special education funding, and a report on staffing/budgeting priorities for the 2017-18 school year. Discussion followed.

<u>Approve Policy 3417 – Catheterization</u> Mr. White moved to approve Policy 3417. Ms. Welch seconded and the motion carried 4-0.

Approve Policy 3421 – Child Abuse, Neglect, and Exploitation – Prevention

Ms. Welch moved to approve Policy 3421. Ms. Tucker seconded and the motion carried 4-0.

Approve Policy 3530 – Student Fund Raising

Ms. Tucker moved to approve Policy 3530. Mr. White seconded and the motion carried 4-0.

Approve Resolution 17-03, Safe Schools for All Students

Superintendent Polm explained that this resolution affirms Port Townsend School District's present non-discrimination policy, and adds guidance to staff if asked for information regarding the immigration status of students or families. Mr. White suggested changing #4 on Page 2 to read: "The Board of Directors will afford equal protection of all members . . ." Ms. Welch moved to approve Resolution 17-03, with the suggested amendment to #4 on Page 2. Ms. Tucker seconded and the motion carried 4-0.

Ms. Welch reported from the Technology Committee that the district is moving email servers from Outlook to Google this summer.
